#### OPEN MEETING:

2. <u>OPEN PUBLIC HEARING TO RECEIVE PUBLIC INPUT REGARDING THE ISSUANCE AND SALE OF \$10,000,000 COMBINED UTILITY SYSTEM REVENUE BONDS, SERIES 2021:</u>

Motion was made by Mr. Howard Burningham seconded by Mr. Len Arave to open the Public Hearing. Motion carried unanimously with Trustees Hansen, Burningham, Lewis, Preece, Arave and Westergard voting "aye".

#### A. PRESENTATION.

The District's two treatment plants were last rehabilitated in the late 1980's. They are due for general rehabilitation. In addition, the Utah Division of Water Quality has reduced the permit limits for nitrogen and phosphorus. The existing plants were never intended or designed to remove these nutrients and new processes have to be added. The 2021 bond will provide funding to complete the South Plant rehabilitation project and the engineering on the North Plant rehabilitation project. This should take us through the end of 2022, after which additional bond funding will be required to complete the project.
